## critical information summary for ISDN2 \$64.95 plan

### Description of the Service

This is an ISDN2 service that can be used to make or receive up to two calls concurrently.

### Minimum Term

This plan has a 24 month minimum term.

### What's Included and Excluded?

No calls are included in this plan.

Additional charges apply for calls not included in your plan. The main charges are:

- Local calls: 15.5c per call
- National calls: 44c per call,
- Calls to mobiles (any network): 44c per minute
- Calls to 13/1300 numbers: 40c per call

Calls to mobiles (any network) are charged in 60 second increments with a first minute minimum call charge of 44c

### Information about Pricing

#### Charges

Your minimum monthly charge for the ISDN2 rental is \$64.95.

The minimum amount you'll pay over the 24 month term for the ISDN2 rental is \$1558.80

#### Early Termination

If you cancel a service or transfer a service away prior to the end of your contract term you will incur an early termination charge of \$220 per channel (\$440 per service).

#### Calls to International Numbers

Calls to Enoxtel's top 10 international destinations are charged at 10c per 30 seconds with a first minute minimum charge of 20c.
